## The final Joint Qalibra/Beneris meeting, Budapest, 10-11 June, 2009

## The Beneris project meeting minutes

The Beneris project had its administrative meeting during the Joint Qalibra/Beneris meeting in Budapest, 10-11 June, 2009. This meeting minutes describes the topics that were discussed and decided for the Beneris project.

#### Agenda

## 1. Dissemination plan

The dissemination plan has been under preparation during the whole project. It has not been finalised due to changed responsibilities and changed ideas of its content. In this meeting, Jouni Tuomisto presented a draft dissemination plan to be accepted. Qalibra and the Scientific Advisory Panel also participated in this discussion.

Decision: The draft dissemination plan was accepted (Appendix 1) with the following changes:

- Opasnet Journal was seen as a very challenging idea, as the high scientific quality should be maintained since the first issue. Therefore, Opasnet publishing could be started with reports instead, which are not necessarily peer-reviewed.
- There is a need to facilitate the use of the Bayesian Belief Network (BBN) software called Uninet that is being developed in Beneris. New user-friendly functionalities will be added (see 3. Reallocation of funding.).
- Analytica Web Publisher will be used for dissemination as well.

## 2. Publication plan

The list of publications expected to materialise from Beneris was updated. It was noted that most of the publications will be scientific peer-reviewed articles, but also a report was planned. Publishing was discussed also with Qalibra, and it was decided that the two projects should aim to publish several articles in a special issue of a relevant journal (e.g. Food and Chemical Toxicology was mentioned). The list of manuscripts was decided to be collected during summer, and the deadline for the joint publication manuscripts was decided to be December 31<sup>st</sup>, 2009.

Also the maintenance of the two Beneris websites (<a href="www.beneris.eu">www.beneris.eu</a> used mainly for dissemination, and <a href="www.pyrkilo.fi/beneris">www.pyrkilo.fi/beneris</a>, used mainly for scientific work within the project) was discussed. It was decided that the former will be merged with Opasnet (en.opasnet.org) and the latter will be merged with Heande project website (heande.opasnet.org). Both of these websites will be maintained and updated by THL for at least three years. This ensures that the information produced by Beneris will be available also in the future.

## 3. Reallocation of funding

Due to the reasons described in the annual reports, FSAI has not used its share of the Beneris budget. In the meeting, the partners were talking about actions that would ensure that the main objectives (especially the dissemination objectives, as the planned FSAI contribution was mainly dissemination) would be achieved in an effective way. Several such actions were identified that would make sure that a piece of work that has been ongoing would be successfully finalised. The actions that were agreed upon are listed below. The total cost of these actions is up to  $15000 \in$  for TUDelft and up to  $32000 \in$  for THL.

- Uninet is the key software for developing and analysing Bayesian nets. However, although it is a functional software, there are further needs to improve the functionalities and user-friendliness. This would decrease the threshold for new users and it would make it easier to disseminate the Beneris methods and other products. Estimated cost: 15000 € for TUDelft.
- Harri Sinkko, a statistician, had been working on the food intake data in Finland. There is further work to be done with the vegetable case (both in Finland and Spain), and in the estimates of pollutant intakes in infants and fetuses. The workload will be ca. 3 personmonths for THL.
- The placenta contaminants did not correlate with mother's diet. This was a surprising finding, but it was thought to be due to the fact that the pollutant concentrations were not normalised for fat content of the placenta. Therefore, there is further work to measure placenta concentrations. Estimated cost 10000-15000 € for THL.
- Beneris has not obtained dioxin concentration data from the Commission despite requests. This issue is still under examination, and if the critical thing is that resources are needed to extract the data from the Commission files, THL can send a person to Brussels to do the work. If this plan materialises, it will cost ca. 3000 € for THL.
- According to the dissemination plan, emphasis will be put to collect and upload existing information to Opasnet and Opasnet Base. Key information will be identified, and people will be hired on hourly basis to do the upload work. Expected additional cost is up to 4000 € for THL.
